## 1. School News

Sports Teams and uniforms – on going issue – does the PTK buy and maintain uniforms for teams and what teams?

- o Sports Team concerns about needing money for uniforms and concern that the PTK is not funding b/c we have money but we've done this several times- we've had a hard time communicating with coaches
- o Caitlin getting a lot of heat from basketball parents other teams have names on their uniforms our boys don't b/c using uniforms we bought with out names that are reused if parents want names on uniforms maybe parents need to buy them

- o Audra suggests that maybe we can be a sponsor and will give a set amount from PTK
- o A problem is league requires money to go through league and one parent didn't want to do that so wanted to give \$ to PTK and have it earmarked for basketball but we can't have earmarked funds
- o We have \$500 from one parent currently we haven't sorted this situation out yet, but Caitlin is looking to give \$ back
- o PTK has always given \$100 to a club but the sports team and uniform situation has become messy
- o Cheerleading uniforms we bought them last year but they aren't embroidered are we going to continue to maintain these or should cheerleaders be purchasing their own as they are hard to reuse?
  - We bought cheerleading uniforms but they aren't embroidered and team wants them to say Blackhawks
  - Tabling it for now they don't need them until next year

  - Casey is taking over for Mr. Stark he has communicated with Ms. Stark

  - Mr. Stark is looking to be done with the club and is happy to explain the process
